Recent Academic Leadership Highlights

In 2005, I founded and continue to be the director of the Indiana Center for Evidence Based Nursing Practice, A Joanna Briggs Center of Excellence. The Center has brought an international perspective to all of our curricula, infused evidence based practice ways of thinking and skills throughout our programs, provided scholarly opportunities for faculty and our clinical partners and led to global interprofessional engagement.

With the 2014 decision to merge two regional campuses of the Purdue University system, I led unification of a Department of Nursing (former Purdue North Central) with the College of Nursing (former Purdue Calumet) to form the College of Nursing at the new university, Purdue Northwest. This required bringing together two faculties, curricula, student bodies and policies. We had to bring the undergraduate curricula together quickly in order to satisfy our state and national accreditation. Most importantly, unification required our faculties and new leadership team to develop a new organizational culture.

In 2015, we launched the first doctoral program at a regional campus of an Indiana public university with our Doctor of Nursing Practice. As a faculty member I contributed to the proposal; as Dean, I contributed to our regional accreditation effort, launched the program and we have graduated our first students. This program has a concentration in knowledge translation which aligns with the College's strengths.

We have just broken ground on a new building that will house the College of Nursing and the Department of Biology. I have led the College team as we negotiated program, space and design. I have worked with our Advancement team to attract small and large donors, including those with naming rights. Anticipated move-in will be Fall of 2020.
